Notice of Occupancy Rights under the Violence Against Women Act

**To all Tenants and Applicants**

The Violence Against Women Act (VAWA) provides protections for victims of domestic violence, dating violence, sexual assault, or stalking. VAWA protections are not only available to women, but are available equally to all individuals regardless of sex, gender identity, or sexual orientation. The U.S. Department of Housing and Urban Development (HUD) and the U.S. Department of Agriculture, division of Rural Development (RD) are the Federal agencies that oversee that the Housing Choice Voucher Program, Public Housing Program, Williamsport Terrace Apartment Complex and the Multi-family properties of Pickaway Terrace, Eden Place and Louise Terrace properties are in compliance with VAWA. This notice explains your rights under VAWA. A HUD-approved certification form is attached to this notice. You can fill out this form to show that you are or have been a victim of domestic violence, dating violence, sexual assault, or stalking, and that you wish to use your rights under VAWA.

**Protections for Applicants**

If you otherwise qualify for assistance under \_\_\_\_\_, you

cannot be denied admission or denied assistance because you are or have been a victim of domestic violence, dating violence, sexual assault, or stalking.

**Protections for Tenants**

If you are receiving assistance under \_\_\_\_\_, you may

Note: Despite the name of this law, VAWA protection is available regardless of sex, gender identity, or sexual orientation.

Note: Housing providers cannot discriminate on the basis of any protected characteristic, including race, color, national origin, religion, sex, familial status, disability, or age. HUD-assisted and HUD-insured housing must be made available to all otherwise eligible individuals regardless of actual or perceived sexual orientation, gender identity, or marital status.

not be denied assistance, terminated from participation, or be evicted from your rental housing because you are or have been a victim of domestic violence, dating violence, sexual assault, or stalking.

Also, if you or an affiliated individual of yours is or has been the victim of domestic violence, dating violence, sexual assault, or stalking by a member of your household or any guest, you may not be denied rental assistance or occupancy rights under \_\_\_\_\_ solely on the basis of criminal activity directly relating to that domestic violence, dating violence, sexual assault, or stalking.

Affiliated individual means your spouse, parent, brother, sister or child, or a person to whom you stand in the place of a parent or guardian (for example, the affiliated individual is in your care, custody or control); or an individual, tenant, or lawful occupant living in your household.

### **Removing the Abuser or Perpetrator from the Household**

The Pickaway Metropolitan Housing Authority may divide (bifurcate) your lease in order to evict the individual or terminate the assistance of the individual who has engaged in criminal activity (the abuser or perpetrator) directly relating to domestic violence, dating violence, sexual assault, or stalking.

If the Pickaway Metropolitan Housing Authority chooses to remove the abuser or perpetrator, the Pickaway Metropolitan Housing Authority may not take away the rights of eligible tenants to the unit or otherwise punish the remaining tenants. If the evicted abuser or perpetrator was the sole tenant to have established eligibility for assistance under the program, the Pickaway Metropolitan Housing Authority must allow the tenant who is or has been a victim and other household members to remain in the unit for a period of time, in order to establish eligibility under the program or under another HUD housing program covered by VAWA, or, find alternative housing.

In removing the abuser or perpetrator from the household, Pickaway Metropolitan Housing Authority must follow Federal, State, and local eviction procedures. In order to divide a lease, Pickaway Metropolitan Housing Authority may, but is not required to, ask you for

documentation or certification of the incidences of domestic violence, dating violence, sexual assault, or stalking.

### **Moving to Another Unit**

Upon your request, Pickaway Metropolitan Housing Authority may permit you to move to another unit, subject to the availability of other units, and still keep your assistance. In order to approve a request, Pickaway Metropolitan Housing Authority may ask you to provide documentation that you are requesting to move because of an incidence of domestic violence, dating violence, sexual assault, or stalking. If the request is a request for emergency transfer, the Pickaway Metropolitan Housing Authority may ask you to submit a written request or fill out a form where you certify that you meet the criteria for an emergency transfer under VAWA. The criteria are:

**(1) You are a victim of domestic violence, dating violence, sexual assault, or stalking.** If the Pickaway Metropolitan Housing Authority does not already have documentation that you are a victim of domestic violence, dating violence, sexual assault, or stalking, the Pickaway Metropolitan Housing Authority may ask you for documentation, as described in the documentation section below.

**(2) You expressly request the emergency transfer.** The Pickaway Metropolitan Housing Authority may choose to require that you submit a form, or may accept another written or oral request.

**(3) You reasonably believe you are threatened with imminent harm from further violence if you remain in your current unit.** This means you have a reason to fear that if you do not receive a transfer you would suffer violence in the very near future.

**OR**

**You are a victim of sexual assault and the assault occurred on the premises during the 90-calendar-day period before you request a transfer.** If you are a victim of sexual assault, then in addition to qualifying for an emergency transfer because you reasonably believe you are threatened with imminent harm from further violence if you remain in your unit, you may qualify for an emergency transfer if the sexual assault occurred on the premises of the property

from which you are seeking your transfer, and that assault happened within the 90-calendar-day period before you expressly request the transfer.

The Pickaway Metropolitan Housing Authority will keep confidential requests for emergency transfers by victims of domestic violence, dating violence, sexual assault, or stalking, and the location of any move by such victims and their families.

The Pickaway Metropolitan Housing Authority's emergency transfer plan provides further information on emergency transfers, and the Pickaway Metropolitan Housing Authority must make a copy of its emergency transfer plan available to you if you ask to see it.

### **Documenting You Are or Have Been a Victim of Domestic Violence, Dating Violence, Sexual Assault or Stalking**

The Pickaway Metropolitan Housing Authority can, but is not required to, ask you to provide documentation to "certify" that you are or have been a victim of domestic violence, dating violence, sexual assault, or stalking. Such request from the Pickaway Metropolitan Housing Authority must be in writing, and the Pickaway Metropolitan Housing Authority must give you at least 14 business days (Saturday, Sundays, and Federal holidays do not count) from the day you receive the request to provide the documentation. The Pickaway Metropolitan Housing Authority may, but does not have to, extend the deadline for the submission of documentation upon your request.

You can provide one of the following to the Pickaway Metropolitan Housing Authority as documentation. It is your choice which of the following to submit if the Pickaway Metropolitan Housing Authority asks you to provide documentation that you are or have been a victim of domestic violence, dating violence, sexual assault, or stalking.

- A complete HUD-approved certification form given to you by the Metropolitan Housing Authority with this notice, that documents an incident of domestic violence, dating violence, sexual assault, or stalking. The form will ask for your name, the date, time, and location of the incident of domestic violence, dating violence, sexual assault, or stalking, and a description of the incident. The certification form provides for including

the name of the abuser or perpetrator if the name of the abuser or perpetrator is known and is safe to provide.

- A record of a Federal, State, tribal, territorial, or local law enforcement agency, court, or administrative agency that documents the incident of domestic violence, dating violence, sexual assault, or stalking. Examples of such records include police reports, protective orders, and restraining orders, among others.
- A statement, which you must sign, along with the signature of an employee, agent, or volunteer of a victim service provider, an attorney, a medical professional or a mental health professional (collectively, “professional”) from whom you sought assistance in addressing domestic violence, dating violence, sexual assault, or stalking, or the effects of abuse, and with the professional selected by you attesting under penalty of perjury that he or she believes that the incident or incidents of domestic violence, dating violence, sexual assault, or stalking are grounds for protection.
- Any other statement or evidence that the Pickaway Metropolitan Housing Authority has agreed to accept.

If you fail or refuse to provide one of these documents within the 14 business days, the Pickaway Metropolitan Housing Authority does not have to provide you with the protections contained in this notice.

If the Pickaway Metropolitan Housing Authority receives conflicting evidence that an incidence of domestic violence, dating violence, sexual assault, or stalking has been committed (such as certification forms from two or more members of a household each claiming to be a victim and naming one or more of the other petitioning household members as the abuser or perpetrator), the Pickaway Metropolitan Housing Authority has the right to request that you provide third-party documentation within 30 calendar days in order to resolve the conflict. If you fail or refuse to provide third-party documentation where there is conflicting evidence, the Pickaway Metropolitan Housing Authority does not have to provide you with the protections contained in this notice.

## **Confidentiality**

The Pickaway Metropolitan Housing Authority must keep confidential any information you provide related to the exercise of your rights under VAWA, including the fact that you are exercising your rights under VAWA.

The Pickaway Metropolitan Housing Authority must not allow any individual administering assistance or other services on behalf of the Pickaway Metropolitan Housing Authority (for example, employees and contractors) to have access to confidential information unless for reasons that specifically call for these individuals to have access to this information under applicable Federal, State or local law.

The Pickaway Metropolitan Housing Authority must not enter your information into any shared database or disclose your information to any other entity or individual. The Pickaway Metropolitan Housing Authority, however, may disclose the information provided if:

- You give written permission to the Pickaway Metropolitan Housing Authority to release the information on a time limited basis.
- The Pickaway Metropolitan Housing Authority needs to use the information in an eviction or termination proceeding, such as to evict your abuser or perpetrator or terminate your abuser or perpetrator from assistance under this program.
- A law requires the Pickaway Metropolitan Housing Authority or your landlord to release the information.

VAWA does not limit the Pickaway Metropolitan Housing Authority's duty to honor court orders about access to or control of the property. This includes orders issued to protect a victim and orders dividing property among household members in cases where a family breaks up.

## **Reasons a Tenant Eligible for Occupancy Rights under VAWA May Be Evicted or Assistance May Be Terminated**

You can be evicted and your assistance can be terminated for serious or repeated lease violations that are not related to domestic violence, dating violence, sexual assault, or stalking committed against you. However, the Pickaway Metropolitan Housing Authority cannot hold tenants who have been victims of domestic violence, dating violence, sexual assault, or stalking

to a more demanding set of rules than it applies to tenants who have not been victims of domestic violence, dating violence, sexual assault, or stalking.

The protections described in this notice might not apply, and you could be evicted and your assistance terminated, if Pickaway Metropolitan Housing Authority can demonstrate that not evicting you or terminating your assistance would present a real physical danger that:

- 1) Would occur within an immediate time frame, and
- 2) Could result in death or serious bodily harm to other tenants or those who work on the property.

If the Pickaway Metropolitan Housing Authority can demonstrate the above, the Pickaway Metropolitan Housing Authority should only terminate your assistance or evict you if there are no other actions that could be taken to reduce or eliminate the threat.

### **Other Laws**

VAWA does not replace any Federal, State, or local law that provides greater protection for victims of domestic violence, dating violence, sexual assault, or stalking. You may be entitled to additional housing protections for victims of domestic violence, dating violence, sexual assault, or stalking under other Federal laws, as well as under state or local laws.

### **Non-Compliance with The Requirements of This Notice**

You may report a covered housing provider's violations of these rights and seek additional assistance, if needed, by contacting or filing a complaint with the Cleveland Field Office (Public Housing and Housing Choice Voucher Programs), the Detroit HUD office (Pickaway Terrace, Eden Place or Louise Terrace) or the Marietta Servicing Office of Rural Development (Williamsport Terrace or Pickaway Terrace).

### **For Additional Information**

You may view a copy of HUD's final VAWA rule at 81 FR 80724, as codified at 24 CFR parts 5, 905, 960, 966, 982 and 983. Additionally, the Pickaway Metropolitan Housing Authority must make a copy of HUD's VAWA regulations available to you if you ask to see them.
